### TOWN OF FOXBOROUGH

June 10, 1778	Chapter 1 AN ACT FOR INCORPORATING CERTAIN LANDS IN THE COUNTY OF SUFFOLK, FORMERLY BELONGING TO THE TOWN OF DORCHESTER, BUT NOW TO THE TOWNS OF WRENTHAM, WALPOLE, STOUGHTON AND STOUGHTONHAM, WITH THE INHABITANTS LIVING THEREON, INTO A TOWN BY THE NAME OF FOXBOROUGH.
January 30, 1833	Chapter 15 AN ACT ESTABLISHING THE DIVIDING LINES BETWEEN THE TOWNS OF SHARON AND FOXBOROUGH, IN THE COUNTY OF NORFOLK.
February 28, 1859	Chapter 47 AN ACT TO SET OFF A PART OF THE TOWN OF SHARON AND ANNEX THE SAME TO THE TOWN OF FOXBOROUGH.
February 26, 1879	Chapter 61 AN ACT TO AUTHORIZE THE TOWN OF FOXBOROUGH TO MAKE CERTAIN PAYMENTS TO THE WIDOW AND CHILDREN OF JOHN A DAVIS.
