- Permit fees are not refundable or transferable.
- Re-inspection fee: when an inspection is requested and the work is not ready, unacceptable, or the building is not accessible, a re-inspection fee of \$30.00 will be charged. The fee shall be paid to the Inspections Office prior to the scheduling of the re-inspection.
- When work that requires a permit is started without first obtaining a permit, the fee will be doubled.
- Mechanical/Sprinkler/HVAC Contract\*: includes all labor and materials.
- Building Permit fees or portions thereof may be waived by the Board of Selectmen for municipal structures.

- Electrical permit fees are not refundable or transferable.
- Electrical contract\*: includes all material and labor costs.
- Licensed electrician may take out calendar year maintenance permit only if employed by firm occupying building. Maintenance permit only covers replacement of switches, receptacles, ballasts, circuit breakers, motors and light fixtures. A separate permit must be taken out for all other electric work, new or replacement.
- Failure to obtain permit within five (5) days from start of work the permit fee will be doubled.
- Re-inspection fee: when an inspection is requested and the work is not ready, unacceptable, or the building is not made accessible to the inspector, a re-inspection fee of \$30.00 will be charged. The fee shall be paid to the Inspections Office prior to the scheduling of the re-inspection.
- When the Electrical Inspector is called out on an emergency after business hours by any Town Official or Department, a charge of \$30.00 per hour will be paid in full to the Inspector. The owner of the building shall pay this expense.
- Upon request, the Town's portion of the Electrical Permit fees for municipal structures may be waived by the Board of Selectmen.

- Permit fees are not refundable or transferable.
- Re-inspection fee: when an inspection is requested, and the work is not ready, unacceptable or the building is not made accessible to the inspector, a re-inspection fee of \$30.00 will be charged. The fee shall be paid to the Inspections Office prior to the scheduling of the re-inspection.
- When work that requires a permit is started without first obtaining a permit, the fee will be tripled.
- When the Gas and Plumbing Inspector is called out on an emergency after business hours by any Town Official or Department, a charge of \$30.00 per hour will be paid in full to the Inspector. The owner of the building shall pay this expense.
- Upon request, the Town's portion of Plumbing and Gas permit fees for municipal structures may be waived by the Board of Selectmen.
