### Safety Net Bracelets:

Margaret spoke with Tom Buckley at the Foxboro Fire Dept. (FFD) about the FCOD purchasing 2 Safety Net Bracelets to donate to the FFD. He was able to get a much lower quote for the doors and the FCOD will contribute toward the cost. He will get more information for our next meeting.
