Employee Insurance Advisory Committee which is made up of all unions across the Town and Schools and all agreed to add a high-deductible health plan to all. Open enrollment is September 1, 2025. Agreement would be entered with each of the Towns 16 individual employee groups for this plan to be offered for the next three years. This can be used as a savings account that moves with the employee both the money that they contribute plus what the Town contributes.
