Operation was granted to be a pickleball court and not a rental space. We recognize that this is a different time but the planning process clearly started months ago and the Town should have been looped in.

Deputy Chief Richard Noonan - The outdoor space has been operational during the World Cup and there have been no issues. 1900 people is not the original allowance but based on the size and scope it works but we can stop all operations at anytime given the amount of staff in that area. The amount of time and energy that it took for the Board and Town departments clearly shows our support of Town businesses.

No TV - still going through the necessary channels. Just utilizing a DJ and stage. Private security, 11 staff, Eleveno managers and hospitality staff.

Porta-Potty solution - Can be separated instead of clustered. Any changes need to be reviewed by Patriot Place, Gillette Team Ops and the Town Building Department.

No large events are on the horizon but if they come up, we want to support the

community.

Brian Earley, General Manager of Patriot Place, was not happy of the way this came about. Changes to the premises and any regards to a private party where that changes the footprint, Foxborough Public Safety will have the final say and this will not happen again.
