This award highlights Bohnert's exceptional expertise in maintaining, troubleshooting, and repairing emergency vehicles, ensuring the department's fleet is safe, reliable, and ready to respond immediately.

Why It Matters

- Offer a friendly connection for veterans who may not realize just how strong their support system is here in Foxborough.

These visits are short, respectful, and focused on sharing helpful information. Volunteers will carry official documentation and will never ask for money or personal financial details.

- Health care and mental health services
- Housing supports and financial assistance
- Education and job training programs
