Needed to work on a protected class of a butterfly species, 13.4 acers reserved for the habitat for butterflies. 30 acer property in total. Signage will be put on the property. Neighborhoods - Atherton, Austin and Oak Street may be curious as to the clearing and maintain the habitat moving forward.

including but not limited to, passive recreational development, trails, vegetation or soil alteration must be approved by the MA Division of Fisheries and Wildlife pursuant to their authorities under G.L. c. 131A et. Seq. Votes of the Conservation Commission in support of this acceptance of land was taken on December 15, 2025 and the Selectboard on December 16, 2025.
